

**HONEYWELL AIRCORE™ LIMITED EDITION PATRIOTIC STEEL
HARNESSE SWEEPSTAKES**

OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN

1. **ELIGIBILITY:** The HONEYWELL MILLER AirCore™ Limited Edition Patriotic Steel Harness Sweepstakes (the “Sweepstakes”) is open only to legal residents of the United States or Canada who are eighteen (18) years of age or older at the time of entry. Employees of Honeywell] or other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations and is void in Puerto Rico and where prohibited by law.

3. **AGREEMENT TO OFFICIAL RULES:** Participation in the Sweepstakes constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
4. **ENTRY PERIOD:** The Sweepstakes begins on 11/5/2019 and ends on 7/31/2020 (the “Entry Period”). Entries submitted prior to or after the Entry Period will be disqualified.
5. **ENTRY:** Submit completed form online. There is a limit of one (1) entry per person and e-mail address. Subsequent entries will be void. Any entries attempted through the use of agencies or robotic, repetitive, automatic, programmed, or similar methods will also be void.
6. **DRAWING:** On or about the 30th of each month, the Sponsor will select the names of the potential winners in a random drawing of all entries received. The odds of being selected depend on the number of eligible entries received. The Sponsor will attempt to notify the potential winners within seven (7) days of the drawing.
7. **REQUIREMENTS OF POTENTIAL WINNERS:** Except where prohibited, the potential winners may be required to complete and return an affidavit of eligibility and liability/publicity release (the “Affidavit/Release”) within seven (7) days of being notified. If a potential winner fails to sign and return the Affidavit/Release within the required time period, an alternate entrant will be selected in his/her place in a random drawing of all entries received. If a potential winner is a minor, his/her parent or legal guardian will be required to sign the Affidavit/Release on the potential winner’s behalf.
